

## Sign the Petition

#### **Frequently Asked Questions**

### Who can sign the petition?

Only voters who live within the boundaries of District 92 can sign the petition form. House District 92 includes parts of Deerfield Beach, Fort Lauderdale, Lauderdale Lakes, Margate, North Lauderdale, Oakland Park, Pompano Beach, and Tamarac). If you're not sure whether or not you reside in the District 92, check the map first.

### Do I have to be a Democrat to sign the petition?

No. You can sign the petition regardless of your party affiliation.

# Does signing your petition mean I have to vote for you?

We'd love to have you vote for Whitney Rawls as the District 92 State Representative. However, signing the petition to get Whitney on the ballot does not constitute an endorsement or a vote for him.

### Which fields do I fill in on the petition form?

You must complete all of the blank fields and sign the petition in your own handwriting. The Florida Division of Elections will only accept original signatures. That means you cannot send a copy, you cannot email the form, and you cannot fax it. It must be printed.
